VI. Hearing for Case #2017, James and Lisa Trautwein:

A. Overview of Case: Applicant: James and Lisa Trautwein,

Property: 16 Quimby Road, Rindge, NH 03461

Request for a Variance from Section 5a of the Wetlands Ordinance for increasing impervious area within 50 ft. of vegetated wetlands, to wit: demolishing dwelling $24x\,36$ replace with dwelling $24x\,43$ with twelve-inch roof overhangs (1170 sq. ft. impervious), replace with dwelling $24\,x\,43$ with a twelve-inch roof overhang about 60% of the structures are within the 50' buffer
