Minutes for Meeting on October 13, 2025

OLD BUSINESS

- FPU Internship and class project – Rogers
 - Signs have been decided for Mattabeseck, project is progressing.
- 250th Declaration of Independence Tree Planting – Lefebvre
 - Location has been finalized and pickup is dependent on hole being dug. Drouin will pick up additional materials for staking and ground cover. Watering logistics and schedule was discussed.
 - Drouin noted positive reaction from Rindge Selectmen in favor of the project.
 - Mellor identified multiple boulders at Tetrault for the 10x6" plaque, dedication ceremony likely in spring-summer 2025 with multiple dates and schedules proposed.
- Conservation Land & Related –
 - Work day October 13 at Ford Wildlife Refuge
 - Successful day with 11 volunteers attending. Lefebvre noted that roots dug may spout again, asked about plan for preventative upkeep which will include spring maintenance.
 - Discussed adding a step at end of bridge, Mellor proposed plank step with excess materials, will update with progress.
 - Contoocook bridge painting
 - Deck was painted, reported good progress.
- Conservationist of the Year (CotY) Award
 - Lefebvre reviewed the parameters for nominations, deadline of November 15. The selection committee is being assembled and will meet after the deadline to review and make decision.
- Merrimack Conservation Grant
 - Dickler noted that grant was awarded for \$4,848. Will update sign proposal and get quantity.

- Synnott asked about key for Tetreault kiosk to add Recreation/Park Steward information. Mellor suggested a sign at/on the playscape for more visibility.
- Drouin noted November 8 workday and asked for commission to consider project ideas by next meeting.
